## PROPOSED CHANGE

APPLICANT SEEKS TO CHANGE STATEMENT OF CLAIM NO. 41J 198907 BY ADDING A PURPOSE OF USE AND PLACE OF USE. THE PROPOSAL INCLUDES THE ADDITIONAL PURPOSE OF MARKETING FOR MITIGATION, AT A FLOW RATE OF UP TO 1.25 CUBIC FEET PER SECOND (CFS) AND VOLUME COMMENSURATE WITH THE CONSUMPTION ASSOCIATED WITH THE HISTORIC WATER USE FOR IRRIGATION (14.6 ACRE-FEET (AF)). THE PRINCIPLE REASON THE WATER RIGHT IS PROPOSED FOR CHANGE AT THIS TIME IS BECAUSE APPLICANTS HAVE ENTERED AN AGREEMENT WITH TINTINA MONTANA, INC., TO SUPPLY WATER TO TINTINA'S BLACK BUTTE COPPER PROJECT, A PROPOSED UNDERGROUND COPPER MINE. UNDER APPLICANT'S PROPOSAL, IT WILL HAVE THE OPTION TO MARKET THE WATER RIGHT FOR MITIGATION PURPOSES DURING ANY GIVEN YEAR OR CONTINUE USE UNDER THE HISTORIC PURPOSE OF IRRIGATION.
